### 4. International DIANA Users Meeting

#### - Budget DIANA Users Meeting 2020

Coen explained the budget for the DIANA Users Meeting 2020. The budget is based on the budgets of the DIANA Users Meeting held in Porto and in Barcelona. The budget is based on 21 participants. On the right side we see the expenses like the fee for the meeting room, activities of the secretary, catering, Social Event. On the left side we see the income like contributions of the members and none members, (PhD)-students and accompanying persons social events.

The contribution of the DIANA Users Association will be  $\in 2.675, --$ . When there are more participants, the contribution of the DIANA Users Association will be less. The budget is adopted by the members.

#### - Structure of the DIANA Users Meeting 2020

There will be organized a workshop around the DIANA module DESIGN, presented by DIANA FEA BV. Coen will fit a part of the text of this workshop Action  $\rightarrow$  19-09.

There is a discussion about study cells and the members decided to organize a pre-study cell to brainstorm about probalistic practice cases. A reliable probabilistic analysis scheme is still under discussion, so it is too early to move the PROBAB module from the hidden feature to the set of main DIANA modules. However the checking codes show  $\beta$  values for the reliability of structures, where a nonlinear analysis results in failure loads, belonging to a certain failure mode, based on extended partial factors for material properties and loads. To bridge this gap a probabilistic analysis can help the engineer by adding also  $\beta$  values for the reliability of a structure. So there is a need to get practical examples from the engineering field.

Ane, Coen, Gerd-Jan and Henco (or a colleague from Henco, Action  $\rightarrow$  19-10) will participate in this study cell to setup an overview of practical examples, which can be useful to show the possibilities . The board will discuss organizing a general meeting of members of the DIANA Users Association during the DIANA Users Meeting 2020 and how to fill this meeting in Action  $\rightarrow$  19-11.

#### 5. Estimation 2020 DIANA Users Association

Coen explained the budget for the DIANA Users Association in 2020.

On the left side we see the expenses like the fees of the meeting rooms during the general meetings of the association, activities of the secretary, costs of the website hosting by the provider, costs of the modifications of the website, the website's maintenance costs and sponsoring the DIANA Users Meeting 2020.

On the right side we see the income like contributions of the members.

The budget is adopted by the members.

### 6. Progress update website DIANA Users Association

Henco noted that a trial version of the website has been made by Communication Team and Henco has access to the CMS management system. He has asked the provider if it is possible to make 2 different registration forms. When Henco has filled the website, the Communication Team will do a final test and then the website will go online. Jolanda will send all abstracts from the DIANA Users meetings sofar to Henco Burggraaf for the website of the DIANA Users Association. Action  $\rightarrow$  19-12. Henco expect that the registrations for the DIANA Users Meeting 2020 will be possible via the website.

## 7. Ideas working groups

1) Proposal for extending NLFEA simulations for Safety Formats.

- Ane noted some papers/reports are finished. The following is finished:
- a set of 9 experiments reinforced beams and 3 experiments lightly reinforced beams with a bending moment failure will be presented in IABSE Wroclaw2020;
- the simulations of structures, Viaduct "De Beek" which has been proof loaded, is presented at IABSE Vancouver2017 and IABSE New York2019.
- simulations of a damaged viaduct will be presented at IABMAS2020 in Sapporo.

All papers will come in the publication list of the DIANA Users Association, the database of DIANA FEA and in the Testsuite of DIANA FEA.

Foreseen papers/reports:

- extended report of the above mentioned 12 reinforced beams 2020-Q1
- paper with 6 prestressed reinforced beams at IABSE Christchurch2020
- extended report of the 6 prestressed reinforced beams 2020-Q3
- paper with at least 6 experiments reinforced slabs(Lantsoght) at IABSE Ghent2021
- paper with affected reinforcement reinforced slab viaduct

- composite behaviour steel-concrete existing slab structure, which has been proof loaded

### 2) Evaluation DIANA Release 10.3.

Gerd-Jan notes that in the first quarter of 2020 all clients in the Netherlands and Belgium will be invited for an evaluation session release 10.3 and they can give feedback in to which direction we have to develop.

3) Workflow DIANA

The workflow DIANA will also be evaluated in the evaluation session of DIANA 10.3. Meanwhile release 0.4 is operational in 2020-Q1. Which release will be evaluated ? Gerd-Jan will make this decision later on.

4) Connection between nonlinear analysis and checking codes

DIANA has a workflow, which shows a close relation with the design checking code of a structure. The NLFEA guideline gives also some practical guidance for a workflow especially for the sequence of the loads, based on the partial factors of the Eurocode or the ModelCode2010. The actual DIANA workflow will be presented in the evaluation session of DIANA 10.3, so here this aspect can be removed.

Other ideas for working groups: Kris: Ground interaction. Peter: is the explicit solver operational and can it be used? Gerd-Jan answers no, it is a hidden feature.
