3. Announcements from the Board

There are no announcements from the Board.

4. Annual report 2022

Maziar Partovi is now the new contact person for DIANA FEA.

It is agreed that the list of members will include who has left and who the new members are **Action** \rightarrow 23-02. There are furthermore no comments on the annual report 2022 after which the annual report is adopted. Ane remarks that there is still a desire to expand the 2022 publication list. He asks the members to see if more publications can be added to the list **Action** \rightarrow 23-03.

5. Financial reports 2022

Coen explains that we made a profit of € 224,-- in 2022. This is because there were slightly more paying members and only 1 lecture evening was held in 2022.

There is still 1 invoice open from Shell but they do not respond to the request to pay. It is agreed that we will book this as a loss on 2023. The equity has remained at the same level and we want to keep it that way. In 2023, there will be slightly more paying members. The financial documents from 2022 have been submitted to the audit committee and the audit committee has granted discharge. In the audit committee Nynke Vollema will be replaced by Marcel 't Hart and Johan den Boon will be replaced by Ab van den Bos. The 2024 budget will be discussed in the second General Meeting of 2023. The financial documents are adopted.

6. 15th International DIANA Users Meeting 2023

So far, 12 abstracts have been submitted, 2 from Valencia and 1 from abroad. The rest come from the Netherlands. There is too little interest after the call for abstracts and the reminder in this meeting and the ratio between the Dutch and international submitted abstracts is also not right. 12 abstracts is too little to fill 2 days. You could still combine it with workshops, but you have to organize these in the summer. That's going to be difficult.

Coen notes that the DUM has always been an important part of the association. Sharing international experiences is very valuable. However, we have too few international members and the involvement of DIANA FEA is different now than it was a few years ago.

It is agreed that the DIANA Users meeting in Valencia will be cancelled. It is also agreed that we will hold a campaign in the 2nd half of this year to recruit more international members $Action \rightarrow 23-04$. Ane is already collecting international DIANA publications. Ricky will create a share via google drive and create a standard email to approach international people and forward it to Jolanda $Action \rightarrow 23-05$. Coen will organize a meeting with DIANA FEA to discuss the collaboration aspects $Action \rightarrow 23-06$.

7. Call for publications 2022 Annual report 2022

This item on the agenda has been dealt with in the Annual report.

8. Study cell "DESIGN" - Ab and Coen

DIANA FEA no longer wants to put energy into Design. They only want to focus on high-end analysis. Coen will raise this during the conversation with DIANA FEA. It is decided to end the study cell.

9. Study cell "Expansion of NLFEA simulations NLFEA Guideline" - Ane

In a conversation with Rijkswaterstaat, Marco Roosen, it was agreed that examples will be analyzed. Marco gave a lecture on this in February. The study cell needs to be given even more structure and expanded.

10. Pre-testing DIANA software

At the beginning of this year we submitted a note to DIANA FEA. Ane has not yet spoken to DIANA FEA about this. DIANA version 10.7 has been released. Witteveen+Bos has been approached for pretesting. Version 10.7 would already be available but the changes in the new version are no longer on the DIANA FEA website.

11. Wish-list

A wish-list has been shared to the members. A number of members have completed the wish-list, but a number still have to fill it in. Ane goes after this.

12. Contest TU-Delft

The contest went ahead and was presented at the fib congress in Istanbul. Two dutch companies have won: ABT and Wagemaker. The intention is that there will be a postdiction. Yuguang Yang is going to talk about this tonight.

13. Announcements from DIANA FEA

There is no one present from DIANA FEA so there are no announcements.

14. Rondvraag

Ricky: there is a LinkedIn page for the DIANA Users Association but we are not the owner. Ricky has therefore created a new page. Ricky will forward the data from this new LinkedIn page to Jolanda so that she can forward it to the members and participants of the DIANA lecture evening.
